¹ The statistics for Wales relate specifically to those appointments that have been made by Welsh Government Ministers.

The overall percentage figures in this statistical analysis relate to ministerial appointments across the United Kingdom for which the Commissioner for Public Appointments has regulatory oversight – these are appointments made by HM Government Ministers and Welsh Government Ministers.

The statistics do not include appointments made by Ministers in the Scottish Government or Ministers in the Northern Ireland Executive that are subject to different regulatory oversight.

Statistical Report 2014-15

These statistics are from the Commissioner for Public Appointments (CPA) and relate to regulated appointments and reappointments made by Ministers from 1st April 2014 - 31st March 2015, in accordance with the 2012 Code of Practice for Ministerial Appointments to Public Bodies.

The data are collected on an annual basis from Governmental Departments representing the Ministers as appointing authorities, and analysed by staff in the Secretariat serving the CPA. All percentage figures have been rounded to one decimal place.

The statistics include 699 appointments and reappointments made to Independent Monitoring Boards that came into the CPA's remit in 2012. In order to enable better comparison with previous years' statistics, totals have also been shown excluding these additional 699 justice sector appointments where appropriate.

HEADLINE MESSAGES

1. Appointments and reappointments (Tables 1 – 4)

- 1,888 appointments and reappointments (chairs 121, members 1,767), compared with 2,150 in 2013-14. This included:
 - ⇒ 1,007 new appointments (chairs 76, members 931);
 - ⇒ 881 reappointments (chairs 45, members 836).

2. Diversity (Tables 5 – 19)

(a) Gender (Tables 5 – 8)

- 819 appointments and reappointments were made to female candidates (45.2% of appointments and reappointments where gender was known) in 2014-15, compared with 820 (39.1%) in 2013-14. This included:
 - ⇒ 434 new appointments (25 chairs, 409 members), 44.3% where gender was known;
 - ⇒ 385 reappointments (18 chairs, 367 members), 46.3% where gender was known;
- 77 appointees either chose not to declare gender or their gender is unknown.

(b) Ethnicity (Tables 9 – 12)

- 124 appointments and reappointments were made to candidates from Black, Asian, or Minority Ethnic (BAME) backgrounds (7.9% of appointments and reappointments where ethnic background was known) in 2014-15, compared with 125 (7.7%) in 2013-14. This included:
 - ⇒ 77 new appointments (7 chairs, 70 members), 9.0% where ethnic background was known;

⇒ 47 reappointments (2 chair, 45 members), 6.6% where ethnic background was known;

- 315 appointees choose not to declare ethnic background or their ethnic background is unknown.

(c) Disability (Tables 13 – 16)

- 65 appointments and reappointments were made to candidates with disabilities (4.6% of appointments and reappointments where disability status was known) in 2014-15, compared with 81 (7.6%) in 2013-14. This included:

⇒ 40 new appointments (2 chair, 38 members), 5.0% where disability status was known;

⇒ 25 reappointments (2 chair, 23 members), 4.2% where disability status was known;

- 481 appointees did not declare disability status or their disability status is unknown.

(d) Age (Tables 17 – 19)

- 723 appointments and reappointments were made to candidates aged 56-65 (42.4% of appointments and reappointments where age was known) in 2014-15, compared with 491 (41.5% in 2013-14);
- 207 appointments and reappointments were made to candidates aged under 46 (12.1% of appointments and reappointments where age was known) in 2014-15, compared with 138 (11.7%) in 2013-14;
- For 184 appointees their age range is unknown.

3. Multiple Appointments (Tables 20 – 22)

- 219 of all appointees have declared that they hold other appointments (26.2%) in 2014-15, compared to 103 (4.8%) in 2013-14;
- At least 116 new appointees (20.9%) already hold other appointments;
- At least 103 reappointees (36.8%) already hold other appointments.

4. Declared Political Activity

- 85 appointments and reappointments were made to candidates who declared political activity (4.5%) in 2014-15, compared with 107 (5.0%) in 2013-14.
